Understanding that as a competitor/coach/trainer/official in the 2011 Commonwealth Youth Games (**the Games**) I am participating in an event which has ongoing international and historical significance, and in consideration of the acceptance of my participation, I agree that completion of this form and my continuing agreement to these conditions in all respects is a pre-condition of entry and eligibility for the Games.

Use of Image and Marketing / Promotional Activities

I agree that my name, image and likeness ('the Images') may be photographed, filmed, broadcast or otherwise recorded during competition or any other events incidental to my participation in the Games. I give my unconditional and irrevocable consent to the Organising Committee (IOM 2011) and the Commonwealth Games Federation (**CGF**) or anyone authorised by them to record the Images during the Games and to copy, publish, broadcast, distribute and communicate the Images to the public by any means, in any format and on any media without payment to me. I also consent to the use of the Images for all other current or future purposes authorised by IOM 2011 or the CGF including marketing and promotional activities in connection with the Commonwealth Youth Games. Any images shall be the IOM 2011's sole and exclusive property for the duration of the Games, and after that, the sole and exclusive property of the CGF. I also release and discharge the IOM 2011 from all claims whatsoever in connection with the use of the Images and my rights in them. I hereby irrevocably waive any and all moral rights in connection with the Images. I further agree that except as permitted by the CGF's executive board, I will not allow my person, name, picture or sports performances to be used for advertising purposes at or during the Games. I further undertake not to perform any act or be involved in any situation that brings the Games, the CGF, IOM 2011 or the official sponsors and partners of these Commonwealth Youth Games entities and the Commonwealth Games movement into disrepute.

Compliance with the Constitution of the CGF and the rules of my sport

I acknowledge and agree that the rules applicable to the Commonwealth Games also apply to the Commonwealth Youth Games and as such I agree to comply with the Constitution of the CGF currently in force, including any amendments made from time to time as available on the CGF website (www.thecgf.com). In particular, I agree to comply with the provisions of the CGF Constitution regarding the eligibility of competitors and rules relating to the identification on personal competition clothing and personal equipment. I also accept and agree to abide by the CGF's rules pertaining to Anti-Doping as detailed within the CGF's Anti-Doping Standards (ADS) adopted for the 2011 Commonwealth Youth Games. I acknowledge that I have been provided with access to a copy of the CGF's ADS for the Commonwealth Youth Games through my Commonwealth Games Association.

As a condition of my entry and participation in the Games I further agree to familiarise myself with and comply with the relevant provisions, rules, statutes and regulations of the CGF, the World Anti Doping Code, my International Federation ('**IF**'), my Commonwealth Games Association ('**CGA**') and my National Federation ('**NF**'). I undertake to notify my CGA and/or my NF immediately should there be any change to my personal information contemplated by this form which relates to my qualification for, attendance at, or participation in the Games.

I agree that I must complete any security and accreditation documentation in the form and by the date requested by the IOM 2011, and I must be eligible to receive and I must continue to hold accreditation from the IOM 2011 during the Games. I acknowledge and agree that I will be held responsible to pay the total cost of damage I cause to any property at the Games accommodation, competition venues or training venues (except where such damage is caused by reasonable wear and tear as a result of training for or competing in the Games).

Waiver and Release

In consideration of my entry and participation in the Games I agree that I participate in the Games at my own risk. I undertake to take all reasonable measures to protect myself from the risks of participation. I agree that I am responsible for all property I bring to the Games sites and that the IOM 2011 and the CGF accept no responsibility for any loss or damage to this property. I release the IOM 2011 and the CGF (and their respective executive members, directors, officers, employees, volunteers, contractors or agents) from any liability for any loss, damage, personal injury, death, economic loss or consequential loss whether in tort, in contract, under statute or otherwise, for any default, failure or negligence (to the extent permitted by law) in relation to my participation in the Games. Where a term of this waiver and release contravenes the law of the relevant jurisdiction under which any legal action is brought it will not apply, however such terms are severable and do not invalidate the remaining terms.

Collection and Use of Information

I acknowledge and agree that my personal information (including health information) can be stored, used and disclosed by the IOM 2011 and the CGF in connection with the organisation, administration, staging and promotion of the Games, the Commonwealth Games and the Commonwealth Youth Games generally, and other activities as contemplated in this entry form.

Resolution of Disputes

I agree that any dispute or differences relating to or arising from my participation in the Games shall be resolved by my CGA, the International Federation ('**IF**') governing my sport, the IOM 2011, and the CGF and if not so resolved shall be submitted to the CGF's Federation Court for resolution.
